Good afternoon Mr May:

My name is Tony Pratt. I work for Woolworths, and am responsible for managing our proposed Development Application relating to land at 233 Argyle St, Moss Vale. You would have received an email on 8 June from our Stakeholder Relations Manager, Denise Bradley, regarding this proposal.

The DA submission has been prepared and is ready to submit. Before we can do so however, we require Owner's Consent from Council. This is because the proposal includes land owned by Council, at 231 Argyle St.

Recently, Council decided to take the matter of owner's consent to the next Council meeting, on 21 June. We understand it is a Supplementary Agenda item, and the report will be published on Council's website tomorrow. We are advised that it will recommend that owner's consent be granted.

We are very keen to see the officer's recommendation endorsed on Wednesday, so we can submit the DA and proceed to the assessment phase. In that regard, you are no doubt aware that:

- provision of owner's consent is only consent to submit the DA. It is not an approval nor endorsement of the DA; nor does it carry any such inference.
- Owner's consent from Council is required just to get the DA process started, during which all of the usual public scrutiny and detailed assessment will be applied to the application.

That being the case, we respectfully request endorsement of the report's recommendation at the meeting on Wednesday, thus enabling us to immediately submit the DA.

I will attend the Public Forum session on Wednesday, to speak in support of the recommendation.
