PURPOSE

To review the traffic management arrangements for the NSW Waratahs vs ACT Brumbies Super Rugby Pacific Trial Game to be held on Saturday 1 February 2025 at Eridge Park, Burradoo.

RECOMMENDATION

THAT the traffic management arrangements proposed by All Area Traffic Services for the NSW Waratahs vs ACT Brumbies Super Rugby Pacific Trial Game to be held on Saturday 1 February 2025 at Eridge Park, Burradoo, be approved subject to the implementation of the approved Traffic Management Plan and approval from the NSW Police Force in accordance with the Guide to Traffic and Transport Management for Special Events for a Class 2 event.

REPORT

REPORT

The NSW Waratahs vs ACT Brumbies Super Rugby Pacific Trial Game is proposed be held on Saturday 1 February 2025 at Eridge Park. Eridge Park is located at the corner of Moss Vale Road and Eridge Park Road, Burradoo. Moss Vale Road is a State Road under the control of Transport for NSW. Eridge Park Road is a local road under the control of Council. Access to the site for cars will be via Elizabeth Street and Wirreanda Road. Access for buses will be via Eridge Park Road and Wirreanda Road.

The expected attendance for the event is 3500 patrons.

There will be onsite parking at Eridge Park that will be limited to 500. Patrons will be encouraged to park in Moss Vale CBD, Bowral CBD and Chevallier College. Berrima Bus Lines will provide shuttle buses from these location to and from the event.

The event activities will start at 11:00am with various rugby games, concluding with the main event between the Waratahs and Brumbies at 3:00pm. The event will conclude at 5:00pm.

Please see attached Traffic Management Plan and Traffic Guidance Schemes for further details.

The proposed traffic management arrangements for the NSW Waratahs vs ACT Brumbies Super Rugby Pacific Trial Game to be held on Saturday 1 February 2025 at Eridge Park, Burradoo, has been developed in consultation with Transport for NSW, emergency services, Bowral Blacks Rugby Club, and local transport services.

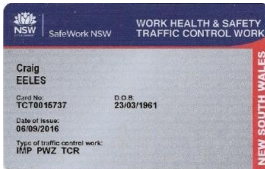

1.1 Introduction

This Traffic Management Plan (TMP)

- updates the successful method of traffic management used at previous Bowral Rugby Club games held at Eridge Park.
 - has been produced in consultation with Event Management, Police, Local Councils, Transport NSW, and other stakeholders.
 - takes into consideration the safety of patrons and event participants, and with emphasis on the safe passage of all traffic and pedestrians either involved in the event or travelling through, past or around the event area.
 - takes into consideration the disruption to the local community, business' and traders.
 - takes into consideration emergency services routes through, past or around the event area.
 - is the document to be referred to by event staff regarding any traffic management at the event.
 - is written as a document for relevant authorities to refer to when considering the issue of any traffic management permits and approvals for the event.
 - is written to ensure that traffic management at the event is implemented in accordance with A.S. 1742.3 - 2019, the Transport NSW 'Traffic Control At Work Sites' manual 2020 (version 6) and the Transport NSW "Guide to Transport Management at Special Events" - 2018 for a class 3 event.
 - has been developed by a traffic management planner with qualifications to Prepare A Work Zone Traffic Management Plan.

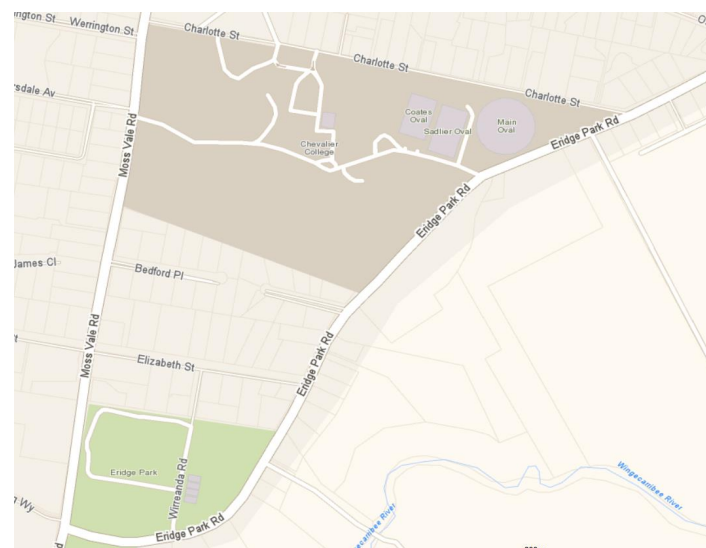
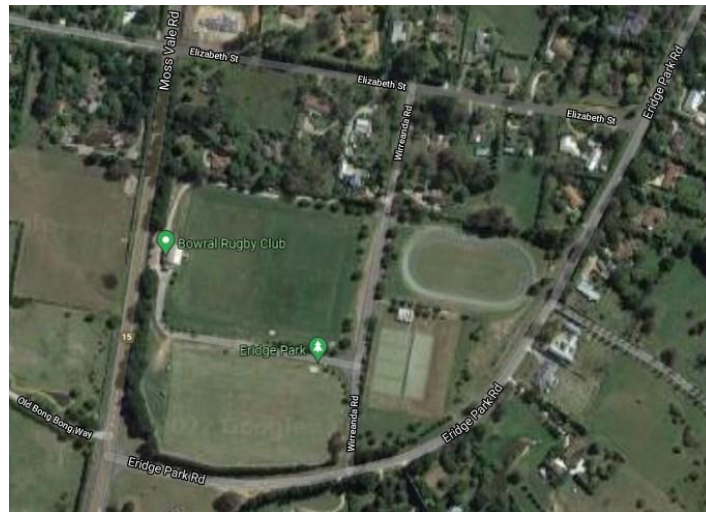
The primary route to the site is via Eridge Park Road, Elizabeth Street and Wirreanda Road.

3.1 Affected Roads / Signs and Devices.

Moss Vale Road, Eridge Park Road, Elizabeth Street and Wirreanda Road around Eridge Park will be affected by event traffic.

Charlotte Street will also be affected by event traffic accessing off-site parking at Chevalier College.

Advance Warning Signs, speed reduction signs and Variable Message Boards will be installed on the roads detailed on the following pages prior to the start of the event, and will be removed as soon as practical after the event.

Parts of the event area will occupy or utilize Wingecarribee Shire property, and roads controlled by WSC.

A S138 permit will be obtained and the proposed traffic management will be approved by the Local Traffic Committee at WSC prior to installing any signs or devices on Council property.

Signs and devices will also be located on Moss Vale Road, which is controlled by Transport for NSW.

A Road Occupancy Licence and Speed Zone Authority will be obtained from TfNSW prior to installing any signs or devices on Moss Vale Road.

3.1 Affected Roads / Signs and Devices.

MOSS VALE ROAD.

Event directional signs will be installed on Moss Vale Road to assist and direct event traffic to the relevant locations.

(a) Eridge Park Road intersection.

Advance Warning Signs and 40 kmh speed limit signs will be installed on Moss Vale Road on the approaches to the intersection of Eridge Park Road to maintain safe traffic flow and assist turning event traffic.

Traffic Controllers will direct and assist with traffic flow at the intersection.

A Variable Message Board (VMB / VMS) will be located on Moss Vale Road on the north bound approach to the Eridge Park Road intersection.

The VMB will display messages to assist & direct event vehicles throughout the event.

(refer to TGS 02 for traffic management at the Moss Vale Road & Eridge Park Road intersection.)

(b) Elizabeth Street intersection.

Advance Warning Signs and 40 kmh speed limit signs will be installed on Moss Vale Road on the approaches to the intersection of Elizabeth Street to maintain safe traffic flow and assist turning event traffic.

Traffic Controllers will direct and assist with traffic flow at the intersection.

A Variable Message Board (VMB / VMS) will be located on Moss Vale Road on the north bound approach to the Elizabeth Street intersection.

The VMB will display messages to assist traffic flow and warn motorists throughout the event.

(refer to TGS 03 for traffic management at the Moss Vale Road & Elizabeth Street intersection.)

(c) Charlotte Street intersection.

Advance Warning Signs and 40 kmh speed limit signs will be installed on Moss Vale Road on the approaches to the intersection of Charlotte Street to maintain safe traffic flow and assist turning event traffic.

Traffic Controllers will direct and assist with traffic flow at the intersection.

A Variable Message Board (VMB / VMS) will be located on Moss Vale Road on the north bound approach to the Eridge Park Road intersection.

The VMB will display messages to assist traffic flow and warn motorists throughout the event.

(refer to TGS 04 for traffic management at the Moss Vale Road & Charlotte Street intersection.)

(d) Chevallier College main gate.

No Right Turn and No Left Turn signs will be installed on Moss Vale Road on the approaches to the Chevallier College main gate.

No Entry signs will be installed on the main gate.

(refer to TGS 05 for traffic management at the Chevalier College gateway.)

3.1 Affected Roads / Signs and Devices.

3.2 Traffic Controllers.

Certified Traffic Controllers will:-

- install Advance Warning Signs and speed reduction signs on all affected roads by 10.00 a.m. on the day of the event.
- maintain safe traffic flow and assist turning traffic during the event.
- remove Advance Warning Signs and return the speed limit to normal on all affected roads after the event.

Traffic Controllers will be on duty during the event as described in the table below.

These numbers are for events at Eridge Park with over 3,500 patrons attending.

TC numbers will be reduced for events with less than 2,500 patrons attending,
due to the reduced number of turning vehicles at the intersections.

Section 4. PARKING.

4.1 Advertising.

Variable Message Boards will be used to advertise the restricted parking at Eridge Park for the event and to direct event vehicles to the off-site parking areas.

All patrons will be informed electronically or through advertising of the restricted parking on site and will be advised to use the shuttle bus service that will be provided from Chevallier College and local towns.

Residents on Elizabeth Street will be letter dropped to notify of the upcoming event and possible traffic delays.

4.2 Roadside Parking restrictions.

There will be roadside parking restrictions in place on Moss Vale Road, Eridge Park Road, Elizabeth Street and Wirreanda Road.

No Roadside Parking signs and flag lines on star pickets will be installed to eliminate roadside parking in these areas.

4.3 Parking Areas.

Access to the pre-paid parking area inside Eridge Park will be via Elizabeth Street and Wirreanda Road.

There will be limited pre-paid parking for 500 cars inside Eridge Park.

Off-site parking at Chevalier College, Moss Vale township and Bowral township.

(refer to TGS 11 for detailed parking areas at Eridge Park & Chevallier College.)

4.3.1 Pre-paid Public car park.

There will be limited pre-paid parking for 500 cars inside Eridge Park.

Traffic controllers will be on duty on Elizabeth Street and Wirreanda Road to monitor non-compliant parking.

RFS persons will be on duty alongside traffic controllers at the Elizabeth Street and Wirreanda Road intersection to check for pre-paid dashboard passes.

4.3.2 Off-site public parking.

Off-site parking will be available at:-

- Chevallier College.
- Moss Vale CBD
- Bowral CBD

Berrima Bus Lines will be the provider of shuttle buses to transport event patrons from the off-site parking areas to Eridge Park.

Section 5. PUBLIC TRANSPORT.

5.1 Shuttle Bus Drop off & Pick up

Event shuttle buses will be operating at this event.

A local shuttle bus service will pick up and drop off off-site parking patrons at Chevallier College, and various locations in Bowral and Moss Vale, to deliver and return patrons to and from Eridge Park.

Shuttle bus access into Eridge Park will be via the Wirreanda Road gateway on Eridge Park Road.

Shuttle buses will exit via Elizabeth Street and Eridge Park Road.

Adequate space inside Eridge Park will be provided to allow for safe and efficient bus movements and to provide safe waiting areas for patrons waiting to be picked up.

5.2 Taxis

A local Taxi service will be the provider of a taxi service between Eridge Park and surrounding areas.

A dedicated taxi rank will be provided inside Eridge Park with a capacity of up to 6 taxis at any one time.

Taxi access to the taxi rank inside Eridge Park will be via the Wirreanda Road gateway on Eridge Park Road.

Taxis will exit via Elizabeth Street.

5.3 Public Drop off & Pick up area.

A public drop off and pick up will be located inside of Eridge Park for public drop off or pick ups.

The drop off & pick up area will have a capacity for up to 10 cars at any one time.

Section 6. WET WEATHER PLAN

6.1 Wet Weather Contingency Plan.

If wet or windy weather becomes excessive on the day of the event, the event organizer may cancel or postpone the event at any time, including during the event.

Event management will meet and consult with WSC staff involved with the maintenance of Eridge Park at least 2 days prior to the event if wet weather is causing concern as to the safety of on-site parking and the possibility of damage to the parking surfaces.

If wet weather prior to the event has caused the public parking areas inside Eridge Park to become slippery or parking on the day of the event may result in the surface of the parking area becoming excessively boggy or damaged, onsite public parking will be prohibited and all public parking vehicles will be directed by VMB messages to park in Moss Vale or Bowral and use the shuttle bus service provided.

At least 800 car park spaces will be available off site in Bowral in the case of wet weather.

At least 1,200 car park spaces overall will be available off site between Bowral and Moss Vale in the case of wet weather.

Additional buses will be implemented to adequately transport patrons to and from the event.

Event patrons will be advised beforehand as much as possible of the car park closure and to use the off-site parking facilities and public transport provided to minimize the number of cars attending the event area.

Public Drop off & pick up, Taxi & extended Shuttle Bus areas will be provided inside Eridge Park to cater for the public transport demand if off-site parking is to be implemented.

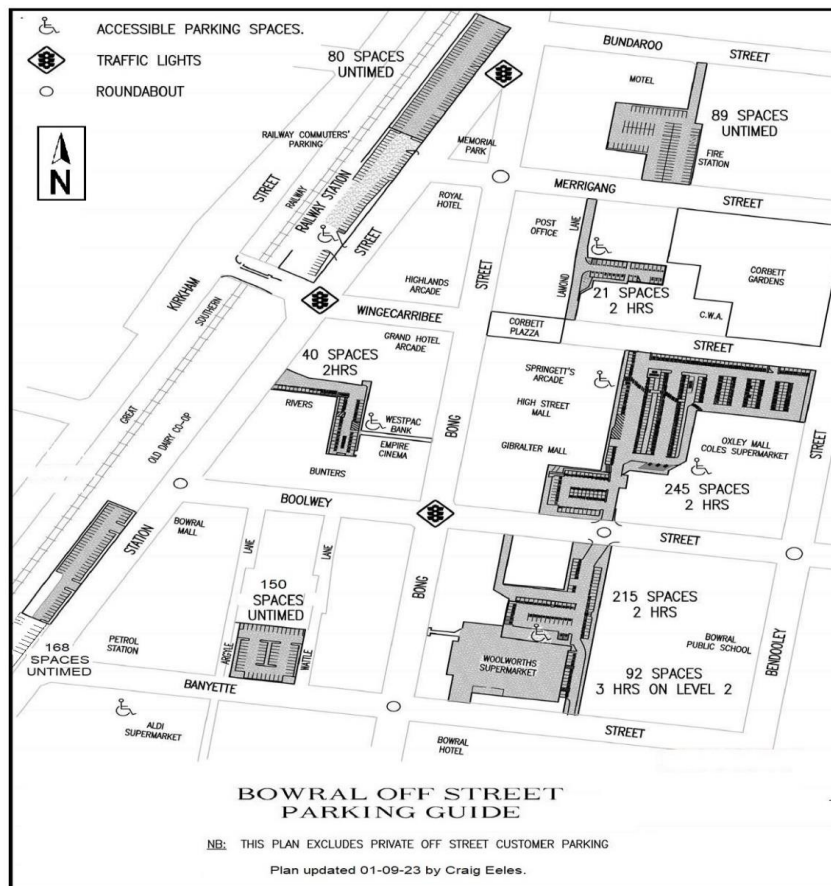

HIGH SCHOOL / LOSEBY PARK PRECINCT. OFF-SITE PARKING

Event participants will be able to park on the shoulders of Park Road and Aitken Road in the Loseby Park precinct, where a shuttle bus service will transport participants to and from the event area.

A sign posted pick up and drop off shuttle bus area will be located at this location.

PARK ROAD

Park Road between Sheffield Road and Aitken Road is 300 m in length.

Excluding 20 % for driveways and residential roadside parking, approximately 240 m will be available for parking each side.

At 6 m per space this equates to 40 cars each side = 80 car spaces available.

AITKEN ROAD

Event participants will be able to park on the shoulders of Aitken Road in the Loseby Oval precinct, where a shuttle bus service will transport participants to and from the event area.

Aitken Road is 300 m in length.

Excluding 30 % for driveways and residential roadside parking, approximately 210 m will be available for parking each side.

At 6 m per space this equates to 35 cars each side = 70 car spaces available.

Section 7. EMERGENCY SERVICES.

7.1 Emergency Vehicles.

Traffic controllers, RFS staff and Parking Marshals will maintain a minimum three-metre-wide access path for emergency vehicles on the access tracks within Eridge Park.

Emergency Vehicle will access Eridge Park via the Wirreanda Road gateway on Eridge Park Road or via Elizabeth Street.

Traffic Controllers will assist emergency vehicles with lights and sirens activated through or around the event area as quickly as it is safe to do so.

In the case of an emergency vehicle needing to travel through the event area on Moss Vale Road or Eridge Park Road with long traffic queues in place, Traffic Controllers will :-

- stop any event traffic exiting onto the road.
- stop all traffic flow in both directions of travel on the road.
- determine that the last car travelling in the opposite direction to the emergency vehicle has passed safely through the event area.
- direct the emergency vehicle onto the right hand side of the road to travel past the traffic queue in the direction of travel.
- direct the emergency vehicle back onto the left-hand side of the road after passing the traffic queue in the direction of travel.
- wait for the emergency vehicle to clear the event area before allowing traffic to flow again on the road.

7.2 Police.

Police will be in attendance at the event.

The local police services located in Moss Vale will be notified of the possible delayed traffic flow Eridge Park Road on the day of the event.

7.3 Ambulance.

The NSW Ambulance Service will not be in attendance at the event

The local ambulance service located in Bowral will be notified of the delayed traffic flow on Eridge Park Road on the day of the event.

7.4 Fire Brigade.

The local fire services located in Moss Vale and Bowral will be notified of the delayed traffic flow on Eridge Park Road on the day of the event.

Section 8. PUBLIC CONSIDERATIONS

8.1 Neighbours

Eridge Park is located nearby to a residential area.

The nearest residents from the location of the event area at Eridge Park is around 100 metres.

These residents have had experienced multiple events held previously at Eridge Park and have shown no objection.

Some spectator and game noise will be created by this event.

The section of Eridge Park Road between Moss Vale Road and Charlotte Street will be affected by event traffic for the duration of event.

8.2 Public Transport

Buses, taxis and other public transport carrying out their business on the days of the event will have minimal disruption and delays to their operations while travelling in the vicinity of Eridge Park.

Section 9. TERRORISM

Event management will refer to the Australian Government 'Guide to Terrorism in Crowded Places' 2017 to determine the level of risk of terrorism for this event, before deciding what measures and / or control methods will be deemed sufficient for this event.

9.1 Suspect activity

Traffic Controllers and Parking Marshals will be given an event pre-start induction, including what to do if suspicious activity is observed. This page of the TMP will be used as part of the induction documentation.

Suspicious activity includes a person/s :-

- observing and / or taking notes of the procedures used by event staff.
- observing and / or taking notes of patron movements.
- taking photos from a car or a distance.
- becoming concerned or trying to conceal themselves if they notice they are being observed by any staff.

The traffic controller or parking marshal must :-

- Not put yourself in any danger or approach anyone acting suspiciously.
- Notify nearby traffic controllers or parking marshals and security staff as soon as possible of your concerns of suspicious activity.
- Notify the traffic manager as soon as possible of your concerns of suspicious activity.
- Take note of suspicious vehicle description including registration plate details if possible.
- Take notes of suspicious persons description including height, build, clothing, appearance, etc.

The traffic manager must :-

- Notify the security manager and site manager as soon as possible of the traffic controllers or parking marshals concerns and the location of the traffic controller or parking marshal.
- Follow the instructions given by either police, the security manager or the event manager.

9.2 Vehicle incursion

Vehicle incursion into areas where large numbers of people are congregated is now being used as a method of terrorist activity resulting in serious injury and death to pedestrians.

An outdoor event poses many risks for vehicle incursion due to the general open ground layout including :-

- Vehicle access from public roads around and into the event area.
- Vehicle access within the event site.
- Vehicular movements beside pedestrian walkways and footpaths.

Measures taken to minimize the risk of this occurring at the event site may include :-

- Minimise or eliminate the vehicle access points to the event area.
This could include restricted access points, detours and public road closures.
- Minimise or eliminate the vehicle access points inside the event site.
This could include internal road closures and restricted access points.
- Install vehicular anti incursion barriers at external road closure points.
- Install vehicular anti incursion barriers at internal incursion points.
- Install vehicular anti incursion barriers beside pedestrian walkways and footpaths.
