OFFICER'S RECOMMENDATION

THAT the Local Planning Panel determines DA23/0503 for construction of a roof covering to a multipurpose equestrian arena at Lot 1 DP618233, No 145 Quarry Rd Bundanoon by APPROVAL for the reasons specified in Attachment 1 to this report.

PANEL REASONS

The Panel has inspected the site and reviewed the consultant planner's assessment report. The Panel was also provided with a supplementary assessment report by Council officers dealing with the Plan of Management applying to the development site under the *Local Government Act 1993*.

The Panel is satisfied that the development is consistent with the applicable provisions of the Plan of Management. The Panel also agrees with the consultant planner's assessment report, subject to the following additional considerations.

The Panel has further considered the visual impact of the proposed structure and has imposed conditions relating to colour selection and landscape treatment as set out below in the Panel's determination. The Panel has also made a number of administrative changes to the draft conditions to address: (a) the scope of the approved development and (b) the legal status of conditions provided to Council by Water NSW and NSW RFS.

The Panel otherwise adopts the reasons for the decision as contained in the consultant planner's report.

PANEL DETERMINATION

- 1. The Panel determines DA23/0503 for construction of a covered multi-purpose equestrian arena at Lot 1 DP618233, 145 Quarry Rd Bundanoon by APPROVAL for the reasons specified in Attachment 1 to the Officer's report with the following amendments:
 - a. Condition 1 to be amended to read:

"Development Consent has been granted in accordance with this notice of determination for the construction of a roof covering to the equestrian arena".

Reason: To confirm the extent of the approved development.

- b. The heading to condition 35 to be amended to read "Water NSW Conditions."
- c. The heading to condition 36 to be amended to read "RFS Conditions."
- d. The following new conditions to be imposed:
 - # The colour of the walls, posts and roof is to be recessive. Details of compliance with this condition must be submitted to the Manager Development Assessment and Regulation for approval prior to issue of the construction certificate.
 - # A landscape plan is to be prepared by a suitably qualified person dealing with the following landscape treatment of the site:
 - a. screen tree planting adjacent to the eastern and northern elevations of the proposed structure; and
 - b. increased screen tree planting along the Quarry Road boundary of the site.

The plan is to be consistent with Planning for Bushfire Protection 2019 and is to take into consideration any operational requirements of the current uses.

The landscape plan is to be submitted to the Manager Development Assessment and Regulation for approval prior to issue of the Construction Certificate.

The approved landscape plan is to be implemented prior to issue of the occupation certificate.
