Hi David,

I have separately sent a reply to your email from last week. I provide this response in relation to your email earlier today to the Administrator and General Manager.

An important clarification on the Council report being considered on Wednesday. The staff referred to in the report, who were without appropriate qualification and training in planning assessment and planning legislation, were former staff working at Council in 2019, 2020 and 2021. None of these staff or contractors work for Council any longer and DAs are only determined by planners.

Over the past two years, instead of being able to focus on assessing the backlog of applications, Council officers have had to spend considerable time dealing with the issues of the past including stormwater issues, delays with releasing new subdivision lots, exposed contamination material, and residents pointing out building exceedances or departures from standards.

Council is the consent authority, and only Council can issue consent for a local development application approval. Wingecarribee Shire Council, like many Council's across the State and nationally, have a shortage of qualified staff. Wingecarribee currently has less planning assessment and building surveying staff than its neighbouring Council's. Council has been, and is continuing to, recruit for the additional personnel required. The NSW State government set the regulated fees for development applications and it is a matter for the State as to whether it wishes to review these fees to reflect the increasing cost to Council's of paid professionals (or consultants) the resourcing of development assessment.

As you are aware, in September last year we commenced the integration of s.68 Local Government Act approvals with DA approvals. Council has increased its development engineering team that work on s.138 Roads Works applications.


Council's new development application tracker provides details on the progress of applications and notifies a registered person when it progresses to the next stage of the process. The report to Council this Wednesday on Council's current processing of applications is very open and transparent, more so than the level of detail than what NSW Council's would generally report. It answers your questions about the reasons for the current assessment times. I would hope that local builders, having the benefit of this knowledge, would then do the right thing by the community and ensure that their contracts do not financially penalise their clients.

I trust that this answers your questions.
